A. #V2014-03: Conduct a public hearing to consider four variance requests from from the Sign Ordinance, Section 21.09.006, Multitenant complex sign design standards, for a new business in Seagoville, Texas (Property Address: 550 North U.S. Highway 175; Property Legal Description: Lot 1R, of the Denny's/Day's Inn Addition, as recorded in Instrument No. 201100310328 of the Deed Records of Dallas County, Texas; Acreage: 2.785± acres).

Applicant: Smarf, LLC

Chairperson Fruin read aloud the following four variances:

- (A) To exceed the maximum height limit of 20 feet by an additional twelve feet (32 feet total).
- B. To exceed the maximum size/area limit of 80 square feet by an additional 432 square feet (512 square feet total).
- C. To waive the minimum acreage requirement of ten (10) acres.
- D. To allow a multitenant sign to be erected on two poles (pole sign).
