A. Review and discuss Article 21.09 Signs, Sections 21.09.001 through 21.09.006 of the City's Code of Ordinances.

The Committee made the following recommendations:

Add to Section 21.09.001(b)(1)(D) A visionary triangle shall be applied to interior and corner lots.

Add a definition for visionary triangle to Section 21.09.005, *General definitions*.

Add the following to Section 21.09.005, *General definitions*:

Alter - To change the **face**, size, shape, outline, intent, footprint or type of sign.

Add (Refer to Section 21.09.006, Multitenant complex sign) to the end of Section 21.09.001(b)(2)(E).

Add the City of Rockwall's definition for agricultural signage to Section 21.09.006, *Definitions and regulations for specific types of signs*, to read as follows:

*Agricultural sign* - any sign identifying the farm or ranch on which it is placed and advertising the produce, crops, animals or poultry raised or quartered thereon. (On-premises)
