After the vote was taken, Chairperson Childress amended his first motion to include, "to allow the City Attorney to review the Committee's recommendation and, if the Committee made a mistake in their recommendation, have the City Attorney define on-premises." The motion to amend the original motion did not receive a second motion.

The Committee made the following recommendations to Section 21.09.006, *Definitions and regulations for specific types of signs*:

1. Under *Interior visible sign* specifications:
 - A. Add the following:
 - (8) Signs excluded are open and closed signs.
 - B. Change the current (8) to (9).
2. Under *Lamppost sign* specifications:
 - A. (3) shall read as follows:
 - Allowed in all zoning districts on private property.
3. Add *Marquee sign*.

The Committee concluded the discussion at *Message center*(1).

For the next meeting, Secretary Kintz was to research the ordinance adopted by City Council approximately two years prior on prohibiting soliciting on the city's and TxDOT's R-O-Ws.
