IV. REQUESTS AND PRESENTATIONS

A. Review and discuss Article 21.09 Signs.

The Committee reviewed Section 21.09.006, *Animated sign through Beacon lights* (Pages 13 through 15), of the draft of recommendations to the Sign Ordinance and discussed the Town Center Zoning District.

The Committee made revisions to the draft of recommendations to the Sign Ordinance as follows:

1. Page 13:

a) Awning sign:

- i. Replace the words "painted or" with the words "digitally printed, screen printed or has vinyl".
- ii. Delete Item No. 1 in its entirety.
- iii. Change the numbering for Item Nos. 2 through 8 to Nos. 1 through 7.
- iv. In the new Item No. 1, delete the word "aggregate".

2. Page 14 and 15:

a) *Banner*:

- i. In Item No. 5, add the word “dedicated” in between the words “per” and “street”.
- ii. In Item No. 13, replace the words “removal by the city at the banner owner’s sole expense” with the word “citations”.
- iii. In Item No. 14, add a new sentence as follows:

..... of the Special Event/Promotion. **Special event cannot exceed five consecutive days without prior administrative approval.** The fourteen (14)-day period will not commence

For the June 24, 2013 meeting, each of the Committee members are to provide a definition for a special event/promotion and be prepared to discuss.
